### **Toxicity**

Toxicity to fish: LC50 - Lepomis macrochirus - > 700 mg/L - 96 h.

Toxicity to daphnia and other aquatic invertebrates: EC50 - Daphnia magna - > 109.1 mg/L - 48 h.

Toxicity to algae: EC50 - Pseudokirchneriella subcapitata (previous names: Raphidocelis subcapitata, Selenastrum capricomutum) - > 110.1 mg/L - 72 h.

### Persistence and degradability

Data specific to the biodegradation of 2,2,4-trimethyl-1,3-pentanediol in mixed cultures were not available(SRC), although 2,2,4-trimethyl-1,3-pentanediol was shown to biodegrade in one pure culture (Pseudomonas aeruginosa) study(1).

### Bioaccumulative potential

Based upon a water solubility of 19,000 mg/L at 25 deg C(1), the BCF for 2,2,4-trimethyl-1,3-pentanediol can be estimated to be 2.4 from a regression-derived equation(2). This BCF value suggests that bioconcentration in aquatic organisms is not an important environmental fate process(SRC).

### Mobility in soil

Based upon a water solubility of 19,000 mg/L at 25 deg C(1), the Koc for 2,2,4-trimethyl-1,3-pentanediol can be estimated to be 19 from a regression-derived equation(2,SRC). This Koc value suggests that 2,2,4-trimethyl-1,3-pentanediol has very high soil mobility(3).

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
