SECTION 4: First aid measures

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

Persistence and degradability

AEROBIC: 2,4-Dibromophenol, present at 100 mg/L, reached 0% of its theoretical BOD in 4 weeks using an activated sludge inoculum at 30 mg/L in the Japanese MTI test(1). An 81% ring degradation was reported for 2,4-dibromophenol, at 100 ppm, over a 4-day period using aerated soil sludge inoculum(2). 2,4-Dibromophenol, present at 251 and 251000 ppm, reached 550 and 0% 14-CO2 evolution after 5 days in a marine water sediment(3). 2,4-Dibromophenol was not degraded over 14 days in a marine water/sediment sample(3). Little activity was observed when 2,4-dibromophenol was tested in a Warburg respirometer using a mixed culture of soil, compost, or mud from a catalytic cracking plant waste lagoon where Pseudomonads predominated(4).

Bioaccumulative potential

A BCF of 16 for 2,4-dibromophenol was deteremined using in carp (Cyprinus carpio) which were exposed over a 28-day period(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

Mobility in soil

The Koc of 2,4-dibromophenol is estimated as 1,300(SRC), using a log Kow of 3.22(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that 2,4-dibromophenol is expected to have low mobility in soil. The pKa of 2,4-dibromophenol is 7.79(4), indicating that this compound will partially exist in the anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(5).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
