Description of necessary first-aid measures

If inhaled

Personal precautions, protective equipment and emergency procedures

Bioaccumulative potential

Based upon a water solubility of 1.5 mg/L at 25 deg C(1), the BCF of chlormethazole can be estimated to be 490 from a regression derived equations(2, SRC). This BCF value suggests that bioconcentration in aquatic organisms may have some importance(SRC); however, it is reported that chlormethazole residues tend to dissipate quickly and do not bioaccumulate(3).

Mobility in soil

The US Dept Agric's Pesticide Properties Database lists a Koc value of 3000 for chlormethazole(1). An experimental Koc value of 2620 has also been reported(2). According to a suggested classification scheme(3), these Koc values suggest that chlormethazole has low to slight mobility in soil(SRC). In soil column leaching tests using sand, sandy loam, clay loam and clay soils, very little chlormethazole leached below a 15 cm depth(4).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
