Bioaccumulative potential

Based on an estimated log Kow of 3.247(2), the bioconcentration factor (BCF) for 2-chloro-4-nitrotoluene can be estimated to be about 173 from a recommended regression-derived equation(1,SRC). This BCF value suggests that bioconcentration in aquatic organisms may be important(SRC).

Mobility in soil

Based on an estimated log Kow of 3.247(2) and a recommended regression derived equation(1), a Koc value of 1,390 can be estimated for 2-chloro-4-nitrotoluene(SRC). This Koc value suggests low soil mobility(3).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
