Description of necessary first-aid measures

If inhaled

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. The aquatic plant, Hydrilla verticillata was shown to remove methylene blue from aqueous solution rapidly; 100, 500, and 1000 ppm methylene blue were 95, 95 and 42% absorbed, respectively, in 180 minutes using 0.5 g Hydrilla in 100 mL solution(1).

Mobility in soil

Laboratory adsorption studies determined that methylene blue was strongly adsorbed to soil organic matter, sodium montmorillonite, and sodium kaolinite(1); desorption studies using three different extraction methods found that only 2% of adsorbed methylene blue was extractable(2).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
