Description of necessary first-aid measures

If inhaled

SYMPTOMS: Symptoms of exposure to this compound include irritation of the skin, eyes and mucous membranes. ACUTE/CHRONIC HAZARDS: This chemical may be harmful by inhalation, ingestion or skin absorption. It is an irritant of the skin, eyes and mucous membranes. When heated to decomposition it emits toxic fumes of carbon monoxide, carbon dioxide and hydrogen chloride gas. (NTP, 1992)
