Description of necessary first-aid measures

If inhaled

Most important symptoms/effects, acute and delayed

SYMPTOMS: Symptoms of exposure to this compound may include irritation of the skin, eye, mucous membrane and upper respiratory tract and cyanosis. Similar chemicals cause methemoglobinemia. ACUTE/CHRONIC HAZARDS: This compound is an irritant and may be fatal if swallowed or absorbed through the skin. Vapor or mist is irritating to the eyes, skin, mucous membranes and upper respiratory tract. When heated to decomposition this compound emits toxic fumes of carbon monoxide, carbon dioxide and oxides of nitrogen. (NTP, 1992)
