### Description of necessary first-aid measures

#### If inhaled

## Most important symptoms/effects, acute and delayed

SYMPTOMS: Symptoms of exposure to this compound include irritation of the eyes and skin. Structurally similar chemicals may cause methemoglobinemia. ACUTE/CHRONIC HAZARDS: This compound may be harmful by inhalation or ingestion. It can cause eye and skin irritation. When heated to decomposition it emits toxic fumes of carbon monoxide, carbon dioxide and nitrogen oxides. (NTP, 1992)

#### **SECTION 6: Accidental release measures**
