SECTION 4: First aid measures

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial

respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

Toxicity

Toxicity to fish: LC50 - *Oryzias latipes* - > 1 000 mg/L - 96 h.

Toxicity to daphnia and other aquatic invertebrates: LC50 - *Daphnia magna* - 6 950 mg/L - 96 h.

Toxicity to algae: EC50 - *Microcystis aeruginosa* - 0.004 mg/L - 7 d.

Persistence and degradability

AEROBIC: Amoxicillin, present at 5.14 mg/L, reached 3 and 5% of its Theoretical BOD in 14 and 28 days, respectively, using effluent inoculum from a municipal wastewater treatment plant in Wyhl, Germany in the Closed Bottle test. Test results suggest amoxicillin is not readily biodegradable. A 92% decrease in the concentration of amoxicillin was attributed to abiotic processes(1). Amoxicillin has been reported to degrade very quickly in soil with a half-life of <1 day(2). Using the Closed Bottle test, amoxicillin, present at 3.27 mg/L, was not biodegraded. Using the Zahn-Wellens test in combination with HPLC-UV-VIS, 94% loss was observed. Complete mineralization by hydrolysis was reported using these two biodegradability tests(3).

Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for amoxicillin(SRC), using a log Kow of 0.87(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of amoxicillin can be estimated to be 100(SRC). According to a classification scheme(2), this estimated Koc value suggests that amoxicillin is expected to have high mobility in soil. An estimated Koc of 865.0 was reported in sludge(3).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
