### SECTION 4: First aid measures

#### Description of necessary first-aid measures

##### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

## **SECTION 6: Accidental release measures**

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

## SECTION 12: Ecological information

### Toxicity

Toxicity to fish: *Oryzias latipes*.

Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - 2.21 mg/L - 48 h.

Toxicity to algae: EC50 - *Pseudokirchneriella subcapitata* (previous names: *Raphidocelis subcapitata*, *Selenastrum capricornutum*) - 2.8 mg/L - 72 h.

Toxicity to microorganisms: EC50 - activated sludge - 149 mg/L - 3 h.

### Persistence and degradability

4-Hydroxybiphenyl at 30 mg/L was inoculated with activated sludge; over 4 weeks, 0% of the theoretical BOD was obtained(1), indicating that this compound is resistant to biodegradation in this system(SRC). A *Pseudomonas* strain, isolated by enrichment culture from activated sludge, was able to utilize 4-hydroxybiphenyl as the sole carbon source(2) while a pure *Alcaligenes* culture, isolated from soil, was not(4).

### Bioaccumulative potential

Measured BCF values of 30-48 and 39-57 were determined in orange-red killifish following a 48 hour exposure period to 2 and 20 ug/L 4-hydroxybiphenyl, respectively(1). According to a recommended classification scheme(2), these BCF values suggest that bioconcentration in aquatic organisms is moderate, not high(SRC).

### Mobility in soil

The Koc of 4-hydroxybiphenyl is estimated as approximately 1300(SRC), using a measured log Kow of 3.20(1) and a regression-derived equation(2,SRC). According to a recommended classification scheme(3), this estimated Koc value suggests that 4-hydroxybiphenyl has low mobility in soil(SRC).

### Disposal methods

## Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

## Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
