## SECTION 4: First aid measures

### Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### Most important symptoms/effects, acute and delayed

Highly toxic by mouth. (EPA, 1998)

### Indication of immediate medical attention and special treatment needed, if necessary

Atropine sulfate injection is used as an antidote to the systemic effects of carbachol.

## SECTION 5: Firefighting measures

### Suitable extinguishing media

Excerpt from ERG Guide 154 [Substances - Toxic and/or Corrosive (Non-Combustible)]: SMALL FIRE: Dry chemical, CO<sub>2</sub> or water spray. LARGE FIRE: Dry chemical, CO<sub>2</sub>, alcohol-resistant foam or water spray. Move containers from fire area if you can do it without risk. Dike fire-control water for later disposal; do not scatter the material. FIRE INVOLVING TANKS OR CAR/TRAILER LOADS: Fight fire from maximum distance or use unmanned hose holders or monitor nozzles. Do not get water inside containers. Cool containers with flooding quantities of water until well after fire is out. Withdraw immediately in case of rising sound from venting safety devices or discoloration of tank. ALWAYS stay away from tanks engulfed in fire. (ERG, 2016)

#### **Specific hazards arising from the chemical**

When heated to decomposition, it emits very toxic fumes of chloride and nitrogen oxides. The aqueous solution is stable even when heated. (EPA, 1998)

#### **Special protective actions for fire-fighters**

Wear self-contained breathing apparatus for firefighting if necessary.

### **SECTION 6: Accidental release measures**

#### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

#### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

#### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

### **SECTION 7: Handling and storage**

#### **Precautions for safe handling**

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store in airtight containers. Protect from light.

### Possibility of hazardous reactions

CARBACHOL CHLORIDE is a carbamate ester. Carbamates are chemically similar to, but more reactive than amides. Like amides they form polymers such as polyurethane resins. Carbamates are incompatible with strong acids and bases, and especially incompatible with strong reducing agents such as hydrides. Flammable gaseous hydrogen is produced by the combination of active metals or nitrides with carbamates. Strongly oxidizing acids, peroxides, and hydroperoxides are incompatible with carbamates.

### Incompatible materials

**STABILITY:** This chemical is sensitive to light (may discolor). Solutions of this chemical in water, DMSO, 95% ethanol or acetone should be stable for 24 hours under normal lab conditions.**REACTIVITY:** This chemical is incompatible with strong bases and strong oxidizing agents. It is also incompatible with active metals, calcium, aluminum, magnesium, zinc and their alloys. This chemical will attack some forms of plastics, rubber and coatings. (NTP, 1992)

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
