## **SECTION 4: First aid measures**

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

## Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse with pure water for at least 15 minutes. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### Most important symptoms/effects, acute and delayed

SYMPTOMS: Slight or brief exposure to this material may cause insomnia, anorexia, a slight fall in blood pressure and body temperature, and, if the exposure is more prolonged, stippled red blood cells, leucocytosis and lead line. Severe exposure may result in marked cerebral involvement with insomnia, excitement and maniacal attacks. ACUTE/CHRONIC HAZARDS: This chemical may be absorbed through the skin. (NTP, 1992)
