## If inhaled

#### Toxicity

Toxicity to fish: LC50 - Pimephales promelas -  $193 \mu g/L - 96 h$ .

Toxicity to daphnia and other aquatic invertebrates: These observations consistently show that the presence of organic matter decreases the bioavailability, uptake, and ecotoxicity of copper in the aquatic environment - Daphnia magna.

Toxicity to algae: Based on the algal biomass, the growth rate, the pigment diversity and the autotrophic index, an optimal concentration range was observed between 1 and 35µg Cu/L. - Pseudokirchneriella subcapitata (previous names: Raphidocelis subcapitata, Selenastrum capricomutum).

Toxicity to microorganisms: see summary - activated sludge of a predominantly domestic sewage.
