If inhaled

AEROBIC: (d)-Propoxyphene was classified as non-biodegradable in sewage treatment(1).

Bioaccumulative potential

An estimated BCF of 260 was calculated in fish for (d)-propoxyphene(SRC), using a log Kow of 4.18(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high(SRC).

Mobility in soil

The Koc of (d)-propoxyphene is estimated as 8.1X10+4(SRC), using a log Kow of 4.18(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that (d)-propoxyphene is expected to be immobile in soil.

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
