### **SECTION 4: First aid measures**

#### **Description of necessary first-aid measures**

##### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

##### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

**Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

**Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

**Most important symptoms/effects, acute and delayed**

Material is a digitalis glycoside. Ingestion can cause death. Material is considered super toxic; probable human oral lethal dose is less than 5 mg/kg, a taste (less than 7 drops) for a 70 kg (150 lb.) person. Persons at risk include those taking drugs for thyroid and renal diseases. Quinidine and diuretics taken concurrently with digoxin can be hazardous. It should be used with extreme care during pregnancy and in nursing mothers. (EPA, 1998)

**Indication of immediate medical attention and special treatment needed, if necessary**

Treat hyperkalemia if greater than 5.5 mEq/L with sodium bicarbonate, glucose with insulin, or sodium polystyrene sulfonate. Do not use calcium; it may worsen ventricular arrhythmias. Treat bradycardia or heart block with atropine; a temporary pacemaker may be needed for persistent symptomatic bradycardia. Ventricular tachyarrhythmias may respond to lidocaine or phenytoin, or to correction of low potassium or magnesium. Cardiac glycosides

**SECTION 5: Firefighting measures****Suitable extinguishing media**

Non-Specific -- Medicines, Solid, Poison B) Extinguish fire using agent suitable for type of surrounding fire; material burns with difficulty. Use water in flooding quantities as fog. Use alcohol foam, carbon dioxide, or dry chemical. (EPA, 1998)

Wear self-contained breathing apparatus for firefighting if necessary.

**SECTION 6: Accidental release measures**

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

## **SECTION 7: Handling and storage**

### **Precautions for safe handling**

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

### **Conditions for safe storage, including any incompatibilities**

Digoxin preparations should be protected from light and stored at 15-25 deg C.

Ensure adequate ventilation. Handle in accordance with good industrial hygiene and safety practice. Set up emergency exits and the risk-elimination area.

#### Eye/face protection

Wear tightly fitting safety goggles with side-shields conforming to EN 166(EU) or NIOSH (US).

#### Skin protection

Wear fire/flame resistant and impervious clothing. Handle with gloves. Gloves must be inspected prior to use. Wash and dry hands. The selected protective gloves have to satisfy the specifications of EU Directive 89/686/EEC and the standard EN 374 derived from it.

#### Respiratory protection

If the exposure limits are exceeded, irritation or other symptoms are experienced, use a full-face respirator.

An estimated BCF of 2 was calculated for digoxin(SRC), using a log Kow of 1.26(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### **Mobility in soil**

The Koc of digoxin is estimated as 120(SRC), using a log Kow of 1.26(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that digoxin is expected to have high mobility in soil(SRC).

## **SECTION 13: Disposal considerations**

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
