# If inhaled

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Aliphatic hydrocarbons and related compounds

### Persistence and degradability

AEROBIC: Oxygen consumption of 7.8 ug/mL over 10 days was reported for dotriacontane using a soil suspension of Hudson-Collamer silt loam soil incubated in the dark at 25 deg C(1).

## Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for dotriacontane(SRC), using an estimated log Kow of 16.06(1) and a regressionderived equation(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of dotriacontane can be estimated to be 7.9X10+8(SRC). According to a classification scheme(2), this estimated Koc value suggests that dotriacontane is expected to be immobile in soil.

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

# Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
