SECTION 4: First aid measures

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Indication of immediate medical attention and special treatment needed, if necessary

Airway protection. Ensure that a clear airway exists. Intubate the patients and aspirate the secretions with a large-bore suction device if necessary. Administer oxygen by mechanically assisted pulmonary ventilation if respiration is depressed. Improve tissue oxygenation as much as possible before administering atropine, so as to minimize the risk of ventricular fibrillation. In severe poisonings, it may be necessary to support pulmonary ventilation mechanically for several days. Organophosphate pesticides

Persistence and degradability

ANAEROBIC: Using adapted bacteria, edifenphos was found to degrade faster under flooded conditions compared to non-flooded conditions(1). Edifenphos was recovered at 42% from autoclaved soils compared to 10% recovery from non-autoclaved soils(1). During a field-study, edifenphos, applied at a rate of 5.0 mg on a paddy field soil in Japan, disappeared in 39 days with a half-life

of 5-6 days(2).

Bioaccumulative potential

Whole fish BCFs for female guppy, male guppy, killifish, gold fish, and white cloud mountain fish are measured as 40.6, 29.3, 28.8, 38.9, and 29.3, respectively(1). According to a classification scheme(2), BCF values ranging from 28.8 to 40.6 for fish(1) suggest bioconcentration in aquatic organisms is moderate(SRC).

Mobility in soil

The Koc of edifenphos is estimated as 1,900(SRC), using a log Kow of 3.48(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that edifenphos is expected to have low mobility in soil(SRC).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
