### Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

SYMPTOMS: Symptoms of exposure to this compound include skin and eye irritation. It can also cause eye damage and nausea via inhalation. ACUTE/CHRONIC HAZARDS: This compound can cause eye damage and skin irritation. When heated to decomposition this compound emits acrid smoke and fumes of carbon dioxide and carbon monoxide. ### Personal precautions, protective equipment and emergency procedures

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## Bioaccumulative potential

An estimated BCF of 260 was calculated in fish for geranyl acetate(SRC), using a log Kow of 4.04(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high, provided the compound is not metabolized by the organism(SRC).

#### Mobility in soil

The Koc of geranyl acetate is estimated as 3,700(SRC), using a log Kow of 4.04(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that geranyl acetate is expected to have slight mobility in soil.

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
