Description of necessary first-aid measures

If inhaled

Specific steps in management include the following. 1. Decontamination. ... 2 Airway. Establish an airway if necessary. ... 3. Respiratory Status. Respiratory distress, in fact, is commonly found in these patients from multiple causes. ... 4. Cardiac Monitoring. ... 5. Cholinesterase Level. ... 6. Pralidoxime. Pralidoxime is the treatment of choice for organophosphate poisoning and should be used for nearly all patients with clinically significant orgnophosphate poisoning, particularly whose patients with muscular fasciculations and weakness. ... 7. Atropine. Atropine is the physiologic antidote for organophosphate poisoning. A trial dose of atropine should be instituted on clinical ground when one suspects organophosphate intoxication. Persistence and degradability

The ultimate biodegradation of isodecyl diphenyl phosphate, initial concn of 19 ppm, was observed to be 13.5, 63.3, and 68.4% of theoretical CO2 evolution in a CO2-evolution screening study using acclimated seed (14 day acclimation period) over an incubation period of 7, 28, and 35 days, respectively. Isodecyl diphenyl phosphate biodegraded 20 to 54% with an addition rate of 13 to 3 1/ppm-hr, respectively, in semicontinuous activated sludge (SCAS) tests and a half-life of about 11 days was observed in a river die-away test for isodecyl diphenyl phosphate at an initial concn of 1 ppm(1).

Bioaccumulative potential

Calculated BCFs of 1,100(1) and 7,500(2) indicate that isodecyl diphenyl phosphate has a moderate potential to bioconcentrate in aquatic organisms(1,SRC).

Mobility in soil

Based upon a measured log Kow of 5.44(1), the Koc for isodecyl diphenyl phosphate can be estimated to be about 21,695 from a regression derived equation(2). According to a suggested classification scheme(3), isodecyl diphenyl phosphate should be immobile in soil and sediment. The low water solubility of 0.75 mg/l at 25 deg C(1) and high Koc value suggest that adsorption to soil and sediment may be an important fate process for isodecyl diphenyl phosphate(4,SRC).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill.
