#### If inhaled

## Bioaccumulative potential

Based upon a measured water solubility of 20,655 mg/L at 25 deg C(1), the BCF for isopropyl formate can be estimated to be about 2.3 from a recommended regression-derived equation(2,SRC) which suggests that bioconcentration in aquatic organisms is not an important fate process(SRC).

#### Mobility in soil

Based upon a measured water solubility of 20,655 mg/L at 25 deg C(1), the Koc for isopropyl formate can be estimated to be about 18 from a regression-derived equation(2,SRC). Using a structure estimation method based on molecular connectivity indexes, the Koc for isopropyl formate can be estimated to be 6(3,SRC). According to a suggested classification scheme(4), these estimated Koc values suggest that isopropyl formate is highly mobile in soil(SRC).

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
