SECTION 4: First aid measures

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms/effects, acute and delayed

This material is highly toxic if swallowed or absorbed through the skin. (EPA, 1998)

Indication of immediate medical attention and special treatment needed, if necessary

1. insure that a clear airway exists by aspiration of secretions if necessary. admin oxygen by mechanically assisted pulmonary ventilation if respiration is depressed. improve tissue oxygenation as much as possible before admin atropine to minimize risk of ventricular fibrillation. in severe poisonings, it may be necessary to support pulmonary ventilation mechanically for several days. 2. admin atropine sulfate iv, or im if iv injection is not possible. ... in moderately severe poisoning: adult dosage and children over 12 yr: 0.4-2.0 mg repeated every 15 min until atropinization is achieved. maintain atropinization with repeated dosage of 0.02-0.05 mg/kg body weight. organophosphate pesticides

SECTION 5: Firefighting measures

Suitable extinguishing media

Non-Specific -- Organic Phosphate, Liquid) Use water spray to absorb vapors. Avoid breathing vapors. Keep upwind. Wear self-contained breathing apparatus. Avoid bodily contact with the material. Wear full protective clothing. (Non-Specific -- Organic Phosphate, Liquid) Use agent suitable for surrounding fire. Use water in flooding quantities as fog. Use foam, carbon dioxide, or dry chemical. When heated to decomposition, this material emits very toxic fumes of nitrogen oxides, phosphorus oxides and sulfur oxides. Stable at neutral pH. Hydrolyzed by acid or alkali. (EPA, 1998)

Special protective actions for fire-fighters

Wear self-contained breathing apparatus for firefighting if necessary.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

SECTION 7: Handling and storage

Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

When heated to decomposition, MEPHOSFOLAN emits very toxic fumes of nitrogen oxides, phosphorus oxides and sulfur oxides. Stable at neutral pH. Hydrolyzed by acid or alkali. [EPA, 1998]. Organophosphates, such as MEPHOSFOLAN, are susceptible to formation of highly toxic and flammable phosphine gas in the presence of strong reducing agents such as hydrides. Partial oxidation by oxidizing agents may result in the release of toxic phosphorus oxides.
