Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting, Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms/effects, acute and delayed

Indication of immediate medical attention and special treatment needed, if necessary

Immediately attention is directed to preservation of the airway, the respiration, and the cardiovascular status. Tracheal intubation in a comatose patient should be followed by gastric lavage with a large bore tube, activated charcoal, and a cathartic. There is no role for forced diuresis in the elimination of methagualone, . In very severe methagualone overdose unresponsive to conservative therapy, with plasma levels exceeding 4 mg/dl, hemodialysis, or more preferably sorbent hemoperfusion, has been shown to be effective in reversing coma, reducing plasma levels, and effecting a complete recovery.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
