Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms/effects, acute and delayed

SYMPTOMS: Allergic reactions to this chemical are manifested by redness and itching of the skin, shortness of breath, anxiety, abdominal pain, restlessness and peripheral vascular collapse. Other toxic reactions include nausea, vomiting, salivation, delirium, circulatory depression, thrombophlebitis, respiratory depression(including apnea), laryngospasm, bronchospasm and hiccups. ACUTE/CHRONIC HAZARDS: This compound may cause allergic reactions in susceptible individuals. This is commonly manifested by skin rash and itching. (NTP, 1992)

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
