### If inhaled

The leaching characteristics of the methyl ester of dinoben in silt loam & clay were determined by the slotted tube technique. further investigations include a study of the extent of hydrolysis of esters in soils. methyl 2,5-dichloro-3-nitrobenzoate (the methyl ester derivative of the dinoben herbicide) resisted leaching in test soils.
