SECTION 4: First aid measures

Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Recommended treatment for adverse effects and/or overdose of midazolam includes the following: Monitoring of respiration, pulse rate, and blood pressure; General supportive measures; Maintenance of a patent airway and support of ventilation; For hypotension, treatment may include iv fluid therapy, repositioning, vasopressors (if indicated), and other appropriate countermeasures; It is not known if peritoneal dialysis, forced diuresis, or hemodialysis is useful in the treatment of midazolam overdose. SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Conditions for safe storage, including any incompatibilities

Midazolam hydrochloride injection should be stored at 15-30 deg C and protected from light. When stored as recommended, the commercially available injection has an expiration date of 2 yr following the date of manufacture. The injection was physically stable when frozen for 3 day periods and allowed to thaw at room temperature.
