#### If inhaled

### **Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. ### **Persistence and degradability**

PURE CULTURE: A strain of bacterium (*Shewanella putrefaciens*) isolated from a mangrove sediment collected from an estuarine wetland in Hong Kong was able to use melatonin as a sole source of carbon and energy under aerobic conditions; using this bacterium isolate, melatonin was completely degraded at initial concentrations 25-150 mg/L within a 144-hr incubation period(1).

### **Bioaccumulative potential**

An estimated BCF of 3 was calculated in fish for melatonin(SRC), using a log Kow of 1.18(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of melatonin can be estimated to be 904(SRC). According to a classification scheme(2), this estimated Koc value suggests that melatonin is expected to have low mobility in soil. Melatonin has pKa values of 16.51 and -0.69 and is uncharged in the entire pH-range(3); therefore, sorption in soil will be determined by the neutral form of melatonin(SRC).

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
