Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms/effects, acute and delayed

SYMPTOMS: Exposure to the compound may cause nausea, nasal dryness, dizziness, headache, nervousness, rapid pulse, sleeplessness and palpitations. It may also cause acute interstitial nephritis, lassitude, restlessness, irritability, aggression, sleep disturbances, psychotic episodes, visual hallucinations, excitability, lack of concentration, paranoid misconceptions, episodic muscular twitchings, tingling feelings in the head, tightness of the chest, rash, tremor and tinnitus. Skin irritation may occur. ACUTE/CHRONIC HAZARDS: When heated to decomposition this compound emits very toxic fumes of carbon monoxide, carbon dioxide, nitrogen oxides and hydrogen chloride gas. (NTP, 1992)
