### Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

SYMPTOMS: Symptoms of exposure to this compound include metallic taste, nausea, anorexia, vomiting, diarrhea, cramps, weight loss and weakness. ACUTE/CHRONIC HAZARDS: When heated to decomposition this compound emits very toxic fumes of hydrogen chloride and nitrogen oxides. (NTP, 1992)
