Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

SYMPTOMS: Symptoms of prolonged exposure to this chemical include dizziness, vomiting, blurred vision, muscular incoordination and paresthesia. ACUTE/CHRONIC HAZARDS: When heated to decomposition this compound emits toxic fumes such as NOx. (NTP, 1992)
