Suitable extinguishing media

Use dry chemical, carbon dioxide or alcohol-resistant foam.

Combustible. May ignite spontaneously on contact with air. Finely dispersed particles form explosive mixtures in air.

Use dry powder, dry sand, special powder. NO carbon dioxide, foam, water. In case of fire: keep drums, etc., cool by spraying with water. NO direct contact with water.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Remove all ignition sources. Personal protection: particulate filter respirator adapted to the airborne concentration of the substance. Cover the spilled material with dry inert absorbent. Vacuum spilled material with specialist equipment. Then store and dispose of according to local regulations.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
