#### If inhaled

Fresh air, rest. Half-upright position. Artificial respiration may be needed. Refer for medical attention.

#### Following skin contact

Remove contaminated clothes. Rinse skin with plenty of water or shower. Refer for medical attention .

#### Following eye contact

First rinse with plenty of water for several minutes (remove contact lenses if easily possible), then refer for medical attention.

#### Following ingestion

Rinse mouth. Do NOT induce vomiting. Refer for medical attention . See Notes.

**SECTION 5: Firefighting measures****Suitable extinguishing media**

Use dry chemical, carbon dioxide or alcohol-resistant foam.

**Specific hazards arising from the chemical**

Not combustible but forms flammable gas on contact with water or damp air. Risk of fire and explosion on contact with water or moisture.

**Special protective actions for fire-fighters**

Use powder, carbon dioxide. NO water. In case of fire: keep drums, etc., cool by spraying with water. NO direct contact with water. Combat fire from a sheltered position.

**SECTION 6: Accidental release measures****Personal precautions, protective equipment and emergency procedures**

Evacuate danger area! Consult an expert! Personal protection: chemical protection suit including self-contained breathing apparatus. Ventilation. Do NOT let this chemical enter the environment. Do NOT wash away into sewer. Collect leaking and spilled liquid in sealable containers as far as possible. Absorb remaining liquid in sand or inert absorbent. Then store and dispose of according to local regulations. NEVER direct water jet on liquid.

**Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Methods and materials for containment and cleaning up**

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

### **Precautions for safe handling**

NO open flames, NO sparks and NO smoking. NO contact with water or moisture. Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.
