Description of necessary first-aid measures

If inhaled

Refer for medical attention. Half-upright position. Artificial respiration may be needed. No mouth-to-mouth artificial respiration.

Following skin contact

Remove contaminated clothes. Rinse skin with plenty of water or shower. Refer for medical attention .

Following eye contact

First rinse with plenty of water for several minutes (remove contact lenses if easily possible), then refer for medical attention.

Following ingestion

Refer for medical attention . Induce vomiting (ONLY IN CONSCIOUS PERSONS!). NO mouth-to-mouth artificial respiration.

SECTION 5: Firefighting measures

Suitable extinguishing media

Use dry chemical, carbon dioxide or alcohol-resistant foam.

Specific hazards arising from the chemical

Not combustible but forms flammable gas on contact with water or damp air.

Special protective actions for fire-fighters

NO water, foam. In case of fire in the surroundings, use appropriate extinguishing media. In case of fire: keep drums, etc., cool by spraying with water. NO direct contact with water.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Evacuate danger area! Consult an expert! Personal protection: complete protective clothing including self-contained breathing apparatus. Do NOT let this chemical enter the environment. Sweep spilled substance into covered containers. Carefully collect remainder. Then store and dispose of according to local regulations.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
