Warfarin is usually available commercially as the water soluble sodium salt (CAS 129-06-6). The physical properties above refer to the parent substance. The symptoms of bleeding do not become manifest after one or two days. Specific treatment is necessary in case of poisoning with this substance; the appropriate means with instructions must be available. Do NOT take working clothes home. This CAS number is for the racemic mixture; other CAS numbers: 5543-57-7 (S-warfarin), 5543-58-8 (R-warfarin)
